TERMS:

Permission to land on any landing strip or helipad on Dundi Lodge is conditional upon the following:

- Acceptance of the disclaimer/waiver below.
- The pilot/operator shall, before departure to Dundi Lodge, ensure that all the passengers and occupants of the aircraft are made aware of this disclaimer/waiver and sign the attached waiver and indemnity.
- The pilot/operator shall, before departure to Dundi Lodge, fax or email this form and the signed waiver and indemnity form to the Dundi Lodge office at 086 5881438 or info@dundilodge.co.za

Permission to land at Dundi Lodge airstrip is conditional upon compliance with these terms. Failure on the part of the pilot/operator to comply strictly with the requirements listed above shall automatically render any permission to land granted under this request to land null and void.

DISCLAIMER/WAIVER:

I/We(name of operator/pilot hereinafter referred to as the User) acknowledge that all the landing strips and helipads at Dundi Lodge are unlicensed and are closed for all air traffic that has not been given written consent to land or take off at Orange Falls /Dundi Lodge by the owners. The closure signs on the landing strips consist of crosses of a single contrasting colour, namely white, displayed horizontally on the threshold of each runway indicating that the entire landing strip is closed for all aircraft. Despite such closure signs, the User may, entirely at its own risk, and subject to all the terms and conditions hereof, utilise such landing strips and helipads. The User hereby indemnifies and holds harmless the Owners, its Directors, employees, agents, members and servants, from all claims that the User or any of its passengers and/or occupants (of the aircraft) may have arising out of any injury (including injury resulting in death) or loss however caused (including gross negligence) sustained by them, arising from the use of any landing strip and/or helipad at Dundi Lodge. The User's employees, agents and servants and any of its passengers or occupants (of the aircraft), shall have no claim for damages of whatsoever nature, against the Owners and any of the employees, agents, members and servants of Dundi Lodge, arising from any loss or injury suffered by it and its passengers or occupants (of the aircraft), howsoever caused and notwithstanding that such loss is attributable to any negligence (including gross negligence) on the part of the Owners, its Directors, employees, agents, members and servants.

PASSENGER WAIVER AND INDEMNITY

I acknowledge that all the landing strips and helipads at Orange Falls /Dundi Lodge are unlicensed and are closed for all air traffic that has not been given written consent to land or take off at Orange Falls/Dundi Lodge. The closure signs on the landing strips consist of crosses of a single contrasting colour, namely white, displayed horizontally on the threshold of each runway indicating that the entire landing strip is closed for all aircraft. I acknowledge that I use the landing facilities at Orange Falls /Dundi Lodge entirely at my own risk.

I agree that Orange Falls /Dundi Lodge, its Directors, its employees, officers or members, shall not be liable for any damage to property, personal injury, death or other harm or loss of whatsoever kind, and howsoever caused, and whether arising from negligence or recklessness.

I indemnify and hold harmless Orange Falls /Dundi Lodge against any claim for loss or damage of any kind, including dependant's claim, brought by any person arising from or in connection with any damage to property, or any harm or injury occurring on the premises, whether or not arising from negligence or recklessness.

I undertake to bring the terms of this indemnity to the attention of any children in my care. I acknowledge that I sign this indemnity of behalf of such children and indemnify Orange Falls /Dundi Lodge against any harm, loss or injury (including death) which may befall them while on the premises, whether or not caused by negligence or recklessness on the part of Orange Falls /Dundi Lodge.

I undertake to read the rules and regulations governing my conduct while on the premises and undertake to abide by them. I furthermore realise that all vehicles and aircraft are liable to be searched. Persons breaching the rules and regulations may be required by management to leave the premises immediately.
